What personally-identifiable information is collected?

We have several areas in this Site where you can submit personal and other information to us. The types of personal information we may obtain or you may choose to provide include:

- Contact information (such as name, e-mail address, and phone number)

- Payment account confirmation from PayPal
- Content you provide (such as job and education history, comments, responses to questions)

Eco Car Wash collects personally-identifiable information in certain areas of the Site when users book one of our car wash and valeting services, request information or a response, sign up/enquire about our Franchise Opportunities. The personally-identifiable information collected may include, without limitation, your contact information (names, mailing and e-mail addresses, phone/ fax numbers). All our bookings are made through Pay Pal therefore your financial information is not made available to Eco Car Wash.

How may my Personal Info be used?

Eco Car Wash uses your Personal Information to operate business activities, fulfil your requests for information, to process your requests/bookings for our services, and to review and consider any employment/franchise - related inquiries that you may submit. The e-mail addresses provided in this regard allow Eco Car Wash to send e-mail to individuals based on the areas of interest that they indicate during or when they log on to our website or contact us directly.

Eco Car Wash do not use the information you provide for marketing purposes and do not share your information with third parties. Please note that when booking one of our services you have the option to pay cash on delivery or to book through PayPal, No financial information is passed to Eco Car Wash apart from confirmation of payment.

Eco Car Wash has a legitimate business interest to use the personal information we collect from you if you apply for employment/franchise or engage in a contractual business relationship with Eco Car Wash Where we have relied on your consent. If you tell us that you do not want us to use this information as a basis for further contact or you wish us to delete any information we might hold, we will respect your wishes.

How do we protect your information?

Eco Car Wash will protect your information by deleting your email booking details no later than six months after your initial booking.

Is personal information disclosed to third parties?

Eco Car Wash does not transfer your personally identifiable information to outside parties. We may also release your information when we believe it is appropriate to comply with the law, enforce our site policies, or protect ours or other rights, property or safety. We do not provide links to third-party Web sites.

Retention

To meet our legal and regulatory obligations, while you are a customer of ours, we hold all information for a period of 6 months. However if you request us to delete any information held, we commit to doing so within 10 days of your request.
